

Probate Notes for June 26, 2015

Probate notes are a recommendation as to the outcome of the petition. Unlike tentative rulings, they do not automatically become adopted as the order of the court. Unless an appearance at the hearing is otherwise required by law, if petitioner submits a proposed order prior to the hearing and the recommendation is to grant the petition, no appearance is necessary. If you are scheduled to appear and there is no probate note issued in your case, you should appear as scheduled. If you wish to continue a matter, you must contact the civil division at (530) 406-6704, at least two (2) court days before your hearing.

CASE: Conservatorship of Cathcart
Case No. CV PB 03-169

It is recommended to approve the verified twelfth account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

CASE: Conservatorship of Davis
Case No. CV PC 14-86

The Court notes the following deficiency: The date of death of the conservatee is unclear in the first account and report of conservator. The account and report states the conservatee's death of death was October 25, 2014. However, the summary of account which closed on the conservatee's date of death, states it closed on July 25, 2014.

CASE: Conservatorship of Field
Case No. CV PC 15-98

The Court notes the following deficiency: The conservatee is not represented by an attorney. (Prob. Code, §§ 2356.5, subd. (f)(1), 1470 et seq.)

CASE: Conservatorship of Funez
Case No. CV PC 12-52

It is recommended to approve the court investigator's report and second verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.) Petitioner is directed to submit a proposed order prior to the date of the hearing.

CASE: Conservatorship of Gorra
Case No. CV PC 09-214

It is recommended to approve the court investigator's report and third verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.) Petitioner is directed to submit a proposed order prior to the date of the hearing.

**CASE: Conservatorship of Herr
Case No. CV PC 08-114**

It is recommended to approve the court investigator's report. (Prob. Code, § 1850 et seq.)

**CASE: Conservatorship of Lainse
Case No. CV PC 09-215**

It is recommended to approve the court investigator's report and third verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.) Petitioner is directed to submit a proposed order prior to the date of the hearing.

**CASE: Conservatorship of Messenger
Case No. CV PC 14-57**

The parties are **DIRECTED TO APPEAR** for the continued hearing on the first account and report of conservator as ordered by the Court on May 29, 2015.

**CASE: Conservatorship of Taylor
Case No. CV PB 99-173**

It is recommended to approve the verified sixteenth account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

**CASE: Conservatorship of Walker
Case No. CV PC 12-176**

It is recommended to approve the court investigator's report and second verified account and report of conservator. (Prob. Code, §§ 1850 et seq., 2620, 1060.) Petitioner is directed to submit a proposed order prior to the date of the hearing.

**CASE: LPS Conservatorship of Baker
Case No. LP SQ 12-26**

It is recommended to approve the verified third account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

**CASE: LPS Conservatorship of Lenton
Case No. LP SQ 08-23**

It is recommended to approve the verified seventh account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

**CASE: LPS Conservatorship of Pickett
Case No. LP SQ 14-29**

It is recommended to approve the verified first account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

It is recommended to approve the verified second account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)
