TENTATIVE RULING

Case: Forchette v. Livezey
Case No. CV CV 14-1520
Hearing Date: March 5, 2015 Department Two 9:00 a.m.

Defendant Holly A. Livezey's motion to compel responses to form interrogatories, set one and request for production of documents, set one, is **GRANTED**. (Code Civ. Proc., §§ 2030.290, subd. (b), 2031.300, subd. (b).) Plaintiff Aiko Forchette shall serve verified answers to the form interrogatories and requests for production of documents, together with all responsive documents, without objections, by March 19, 2015.

Defendant's unopposed request for monetary sanctions against plaintiff and plaintiff's counsel is **GRANTED IN PART** in the amount of \$960.00. (Code Civ. Proc., §§ 2023.010 et seq., 2030.290, subd. (c), 2031.300, subd. (c); Cal. Rules of Court, rule 3.1348; Decl. of Jeremy Jessup, ¶ 11.) Sanctions are not granted for time not yet incurred. Plaintiff and plaintiff's counsel, jointly and severally, shall pay the monetary sanctions to defendant by March 19, 2015.

If no hearing is requested, this tentative ruling is effective immediately. No formal order pursuant to California Rule of Court 3.1312, or further notice is required.

Case: Portfolio Recovery Associates, LLC v. Gutierrez

Plaintiff Portfolio Recovery Associates, LLC's unopposed motion for an order that matters in its requests for admission, set one, be deemed admitted is **GRANTED**. (Code Civ. Proc., § 2033.280.)

The unopposed request for monetary sanctions against defendant Gildardo Gutierrez is **GRANTED** in the amount of \$332.50. (Code Civ. Proc., §§ 2023.010 et seq., 2033.280; Cal.

Rules of Court, rule 3.1348; Decl. Charles Glauberman, ¶ 5.) Defendant shall pay the monetary sanctions to plaintiff by March 19, 2015.

If no hearing is requested, this tentative ruling is effective immediately. No formal order pursuant to California Rule of Court 3.1312, or further notice is required.
