

## Probate Notes for January 25, 2019

Probate notes are a recommendation as to the outcome of the petition. Unlike tentative rulings, they do not automatically become adopted as the order of the court. Unless an appearance at the hearing is otherwise required by law, if petitioner submits a proposed order prior to the hearing and the recommendation is to grant the petition, no appearance is necessary. If you are scheduled to appear and there is no probate note issued in your case, you should appear as scheduled. If you wish to continue a matter, you must contact the civil division at (530) 406-6704, at least two (2) court days before your hearing.

**CASE: LPS Conservatorship of Chand**  
**Case No. LP SQ 18-3**

It is recommended to approve the verified first account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

Petitioner shall submit a proposed order prior to the hearing.

**CASE: LPS Conservatorship of Hall**  
**Case No. LP SQ 11-2**

This probate matter will be heard in **Department 6.**

It is recommended to approve the verified eighth account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

Petitioner shall submit a proposed order prior to the hearing.

**CASE: Conservatorship of Jimenez**  
**Case No. CV PC 11-212**

It is recommended to approve the verified fourth account and report of the conservator and to grant the petition for allowance of fees to the conservator and their attorney. (Prob. Code, §§ 1850 et seq.; 2323, 2628.)

The Court notes the following deficiency: the verified first account and report of the trustee of the Leo Jimenez Special Needs Trust does not state the last known address of the beneficiary as required. (Cal. Rules of Court, rule 7.902.)

**CASE: LPS Conservatorship of Lee**  
**Case No. CV PB 92-20110**

It is recommended to approve the verified twenty-seventh account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

Petitioner shall submit a proposed order prior to the hearing.

**CASE: Matter of the Eugene N. Stille Family Revocable Trust  
Case No. CV P2 18-206**

The parties are directed to appear.

**CASE: LPS Conservatorship of Tsobanoudis  
Case No. LP SQ 12-64**

It is recommended to approve the verified sixth account and report of conservator and to grant the petition for reappointment of conservator. (Welf. & Inst. Code, § 5350 et seq.)

Petitioner shall submit a proposed order prior to the hearing.
