

## **Probate Notes for June 26, 2020**

Probate notes are a recommendation as to the outcome of the petition. Unlike tentative rulings, they do not automatically become adopted as the order of the court. Unless an appearance at the hearing is otherwise required by law, if petitioner submits a proposed order prior to the hearing and the recommendation is to grant the petition, no appearance is necessary. If you are scheduled to appear and there is no probate note issued in your case, you should appear as scheduled. If you wish to continue a matter, you must contact the civil division at (530) 406-6704, at least two (2) court days before your hearing.

2. Petitioner failed to establish that the amount of bond should be \$0.00, that the bond was waived, or that the estate consists solely of public benefits. (Prob. Code, § 2320 et seq.)

**CASE:           Conservatorship of Serrato**

It is recommended to approve the 20<sup>th</sup> verified account and report of conservator and to grant the petition for reappointment of conservator. (Welf & Inst. Code, § 5350.)

Petitioner is directed to lodge an order with the Court prior to the hearing.

**The following probate matters will be heard in Department Ten:**

**CASE: Limited Conservatorship of Baffa  
Case No. CV PC 20-18**

The Court notes the following deficiencies:

1. Proof that the citation and petition were served on the proposed conservatee at least 15 days before the hearing has not been filed with the Court. (Prob. Code, § 1824.)
2. Proof that the notice of hearing (form GC-020) and a copy of the petition were served on the required parties (including the ALTA Regional Center), has not been filed with the Court. (Prob. Code, §§ 1822, 1827.5.)
3. A capacity declaration (form GC-335) has not been filed with the Court. (Prob. Code, §§ 1881, 1890.)
4. Petitioner failed to provide the address for conservatee's father and paternal relatives.

**CASE: Limited Conservatorship of Browne  
Case No. CV PC 14-190**

It is recommended approve the court investigator's report for continuation of the conservatorship. (Prob. Code, § 1850 et seq.)
